An Act to amend the *Evidence (National Uniform Legislation) Act*

The Legislative Assembly of the Northern Territory enacts as follows:

1 Short title

This Act may be cited as the *Evidence (National Uniform Legislation) Amendment Act 2015*.

2 Commencement

This Act commences on the day fixed by the Administrator by *Gazette* notice.

3 Act amended

This Act amends the *Evidence (National Uniform Legislation) Act*.

216 Definitions

In this Part:

amending Act means the *Evidence (National Uniform Legislation) Amendment Act 2015*.

commencement means the day on which the amending Act commences.

217 Application of section 19

- (1) Section 19, as amended by the amending Act, applies to a proceeding commenced on or after the commencement.
- (2) If a proceeding commenced before the commencement, section 19, as amended by the amending Act, applies to that part of the proceeding that takes place on or after the commencement, other than any hearing in the proceeding that commenced before the commencement and:
 - (a) continued on or after the commencement; or
 - (b) was adjourned until the commencement or a day after the commencement.

8 Expiry of Act

This Act expires on the day after it commences.
